Hon. J B Bloom (DA) to ask the Premier:

Further to the reply to Question 5.PR019 on 10 May 2021 concerning all investigation reports concerning irregularities or alleged corruption that have been handed over to the Special Investigating Unit (SIU), will the Premier please indicate:

- why has the Honourable Premier not adhered to his undertaking (i) that the final consolidated report would be shared with the Legislature at the end of June last year;
- (ii) how many individual reports are there;
- (iii) why will individual reports not be made public as well;
- approximately how much in Rands and cents is estimated in total (iv) to have been lost to corruption according to these reports; and
- (v) on what firm date will the consolidated report be made public?

QUESTIONS FOR ORAL REPLY TO THE EXECUTIVE (i.t.o Rule 134)

4.SP001

Hon. I E Mukwevho (EFF) to ask the Member of the Executive Council for Sport, Arts, Culture and Recreation:

Understanding that the Department has the responsibility to work in an integrated manner to create an enabling environment that provides universal access to sport, arts, cultural activities, library, archival services and facilities; and identifying, promoting and preserving heritage. As the EFF, we are aware that the department continues to dismally fail to identify, develop and nurture sport and artistic talent for competitive and major events to name but a few of its objectives. Will the MEC respond to the following:

- when will the department open the Merafong Library and (i) Multipurpose centre in Extension 4? (In your response, provide the exact details therein)
- (ii) how much did the department pay for that centre? (In your response, provide the exact amount in rands and cents)
- (iii) how much is the department paying for the security at the

centre? (In your response, provide the exact amount in Rands and Cents and the name of the company contracted therein)

- (iv) what are the names of the various suppliers contracted to provide resources to the clinic? (In your response, provide details of the specified resources that each supplier is contracted to provide); and
- (v) what features that would benefit the entire community are there in the Multi-purpose centre?

4.PS010 Hon. J J Hoffman (VF-Plus) to ask the Member of the Executive Council for Community Safety:

It is true that no member serving in law enforcement, Metro police and or South African police service may have a criminal record.

Thus, any member serving with a criminal record should be immediately dismissed.

Can the MEC indicate:

- (i) how many SAPS Members are serving with criminal records;
- (ii) how many Metro police members have criminal records or charges pending;
- (iii) how many of these members have competency to carry a state firearm;
- (iv) how regularly are these records checked or reported; and
- (v) how many members in these departments have been dismissed for the above-mentioned contradictions for the last financial year?

4.PS011 Hon. J J Hoffman (VF-Plus) to ask the Member of the Executive Council for Community Safety:

As law enforcement officers are constantly more involved in shooting incidents as a result of the crime surge. Accidents do occur.

With the above-mentioned fact in mind the law enforcement agencies must mitigate and evaluate these risks and as the development for community safety we should take note of the statistics.

Can the MEC indicate:

- Shooting incidents where civilians and or assistants were injured by officers, JMPD, EMPD, TMPD, SAPS Gauteng, Gauteng Traffic and Municipal Traffic;
- (ii) what the cost in civil claims are for the last two financial years; and
- (iii) what disciplinary actions have been initiated and finalized?

4.HL015 Hon. J B Bloom (DA) to ask the Member of the Executive Council for Health:

Regarding the CT Scanner at the Rahima Moosa Hospital, will the MEC please indicate:

- (i) when did this CT Scanner cease functioning;
- (ii) why did this CR Scanner break;
- (iii) how have patients been affected by the broken CT Scanner;
- (iv) what accounts for the delay in fixing this machine; and
- (v) when will this machine be fixed?

4.HL016 Hon. C Mabala (EFF) to ask the Member of the Executive Council for Health:

With regards to the vandalism at Anglo Ashanti Hospital. Would the MEC please indicate:

- what informed a decision by the department to decommission the hospital after spending almost half a billion on renovations and refurbishments;
- (ii) how much, in rand and cents, of the movable and immovable assets were stolen and vandalised;
- (iii) how much, in rand and cents, has already been paid so far to the security company tasked with protecting and looking after this institution;
- (iv) what is the department's plan to recover the money that has already been spent on renovations, refurbishments as well as security arrangements for a property that does not belong to the Gauteng Provincial Government; and
- (v) are there any consequence management in place for the individuals who were involved in the wastage of almost half a billion rand of taxpayers' money?

4.HL017 Hon. C Mabala (EFF) to ask the Member of the Executive Council for Health:

With regards to the R 462 565 433.11 spent so far on the upgrading and refurbishing the Anglo-Ashanti Hospital in the West Rand. Will the MEC please indicate:

- why did the GDOH mislead the House, the Health Portfolio Committee, and the people of Gauteng by saying that Anglo Gold mining company donated the facility to the GDOH during the peak of Covid-19 pandemic in the province;
- (ii) why did the department spent so much money for the upgrading and refurbishment of this facility knowingly that it does not belong to the department;
- (iii) what informed these reckless decisions (in your response please indicate if there was any consultation with legal services in your department);
- (iv) with regards to (i) above, is the any documentary proof that the facility was donated to the department by Anglo Gold Ashanti (please provide this proof to the House for record purposes); and
- (v) regarding (i) above, can the department issue both written and oral apology to this House, the Health Portfolio Committee, the people of Gauteng, and by extension, the entire country for misleading them and for being dishonest?
