Understanding that there are substantial increases in food prices and that honoraria for volunteer food handlers has been significantly reduced, Will the MEC respond to the following:

- what (a) are the effects of budget cuts on feeding schemes in each region and (b) is the total number of meals that have had to be reduced as a result of budget cuts;
- (ii) what measures has the department put in place to ensure that all learners who are entitled to school feeding schemes are getting their meals every day;
- (iii) how many contracts relating to the School Nutrition Programme in Gauteng were awarded between 2016 to date; and
- (iv) how many of the contracted service providers have failed to adequately implement the school nutrition programme terms?

### 4.ED006 Hon. I E Mukwevho (EFF) to ask the Member of the Executive Council for Education:

Following reports that The Department of Basic Education suffered financial losses of more than R300 million due to damages of schools during the violent unrest in Gauteng and KwaZulu-Natal. As the EFF, we are aware of the fact that the damage caused due to the torching and theft in the schools will have a negative impact on the implementation of the recovery plan once the lockdown is lifted. With this in mind, will the MEC respond to the following:

   (a) repaired and (b) re-open; if not, why not; if so, what are the relevant details; and
- (iii) where are the affected learners accommodated where schools were closed due to vandalism?

- (iv) why do the police at Mafatsane police station not have offices (In your response, indicate why then police turn people away claiming not to have offices while working under horrid conditions); and
- (v) what mechanisms has the department put in place to prevent further burglaries across police stations in the province?
