
### Response:


# **Graphic 1: Rail Trips**








### Graphic 2: Bus Trips

- The GMA estimates that, directly as a result of the pandemic, over R1.7 billion of fare revenue has been lost. These losses have been shared between the Province and the Concessionaire and will continue to be shared until the situation is normalised.
- At this stage of the financial year, we do not know the outcome of the ridership growth for the financial year and thus the full impact on the Patronage Guarantee. However, it must be noted that in terms of the Concession Agreement the Patronage Guarantee remains capped at its maximum and will continue to be capped until the average number of rail and bus passengers goes above what is known as the Concessionaire's Demand Forecast (CDF) and hence does not yet result in any increases in the Patronage Guarantee.





#### **Question 6**

The entity should indicate additional source of revenue that was utilised in the quarter under review.

#### Response:

The additional sources of revenue in the quarter under review is made up of R364,000 from the sale of scrapped assets and R1,991,000 made up of interest earned in the current quarter and R1,809,000 from income earned from operating the DLTCs in the Gautrain stations.
