The petitioner alleges that there is a sinkhole within a few meters of the school which poses a safety risk to the learners as well as staff members and the community. He further alleges that the sinkhole has been there for the past two (2) years, but nothing has been done to remedy the situation even though Merafong Local Municipality is aware of the problem. He therefore requests for the urgent intervention of the Legislature as the sinkhole is deepening and widening by the day. Councillor was engaged several times regarding the matter, yet the Councillor did not provide an amicable solution which means the outcome of the engagements with the Councillor were ineffective.
