




 The Public Protector is an independent Constitutional institution whose mandate, derived from section 182 of the Constitution of the RSA, 1996 read with section 181 of the Constitution, is to support and strengthen constitutional democracy by investigating and redressing maladministration or improper conduct in state affairs.

- Section 182 of the Constitution states that:
- "(1) The Public Protector has the power as regulated by national legislation
- a) to investigate any conduct in state affairs, or in the public administration in any sphere of government, that is alleged or suspected to be improper or to result in any impropriety or prejudice;






- (2) The Public Protector has the additional powers and functions prescribed by national legislation.
- (3) The Public Protector may not investigate court decisions.
- (4) The Public Protector must be accessible to all persons and communities.
- (5) Any report issued by the Public Protector must be open to the public unless exceptional circumstances, to be determined in terms of national legislation, require that a report be kept confidential."


"When remedial action is binding, compliance is not optional, whatever reservations the affected party might have about its fairness, appropriateness or lawfulness. For this reason, the remedial action taken against those under investigation cannot be ignored without any legal consequences."

OUTREACH PROGRAMME



- A constitutional obligation of PPSA is to be accessible in terms of Section 182(4).
- An outreach programme with specialised outreach officers are dedicated to make the office accessible by reaching out to those remote communities who cannot access the office via telephone, fax, post or visit.
- Community radio stations and complaint drop boxes are also utilized to reach out to the far flung areas of the province.
- The PPSA conducts joint collaborative activities with State Organs and other State Agencies to maximize access to information.
- Signing of MoU`s to formalise the working relationship with State Institutions. Adherence to investigations timeframes, information sharing, expediency in resolving customer complaints and sharing resources and platform in programmes such as outreach and awareness and





Systemic Investigations by the Public Protector



- Systemic Investigations by the Public Protector focus on structural administrative deficiencies whose impact transcends the experience of individual complainants.
- The intention of systemic investigations is to address issues affecting larger groups and in so doing, make a much broader impact with appropriate remedial action.
- Experience has indicated that once systemic root causes and process failures have been discovered and cured, the influx of complaints lodged with the PPSA from various complainants, about the same/similar issues are reduced substantially.






Assessment of Complaints/Panel: Determine jurisdiction acceptance of complaint and referral to appropriate institution.

SECTION 6 (4) (c) (ii) -The Public Protector shall, be competent- if she deems it advisable, to refer any matter which has a bearing on an investigation, to the appropriate public body or authority affected by it or to make an appropriate recommendation regarding the redress of the prejudice resulting there from or make any other appropriate recommendation she deems expedient to the affected public body or authority.




CHALLENGES FACED BY THE PUBLIC PROTECTOR DURING THE INVESTIGATIONS



- Implementation of remedial action of the reports of the Public Protector.
- Non acknowledgement complaints referred to the Institutions and non submission of progress and close-out report on matters referred to the Institutions
- Lack of feedback to the complainants on matters referred to Institutions resulting in complainants returning to PPSA for further intervention.
- Undue delay to respond to allegations letters send to State Institutions
- Failure to comply with response turnaround times.
- ADR: Non attendance and representatives not having the authority to take decisions.
