QUESTIONS FOR ORAL REPLY TO THE EXECUTIVE (i.t.o Rule 134)

4.SP001 Hon. M S Chabalala (DA) to ask the Member of the Executive Council for Sport, Arts, Recreation and Culture:

With regard to the Gauteng Sports Awards Announcement of Finalists and the Gala Event held in 2022 and 2023, could the MEC please indicate:

- (i) what services were rendered by the following service providers
 Ngrande, Victory Plus Projects and Services, Phaka Seboja,
 Leonb Holdings, Dream florah, Maletsatsi Holdings, MJ& LB PTY
 LTD, Gauteng Sports Confederation during the Gala event;
- (ii) for each Gala event, how many finalists attended;
- (iii) how many people did the department invite for each Gala event; and
- (iv) what services were rendered by service providers during the Announcements of Finalists for both 2022 and 2023?

4.SD003 Hon. R Nt'sekhe (DA) to ask the Member of the Executive Council for Social Development:

During the committee meeting of the 1st of March, the MEC and the department indicated that "during the time when food banks did not have food, food parcels continued to be distributed". With that in mind:

- (i) which organisations were distributing food during the period when food banks had no food;
- (ii) when were these organisations recruited;
- (iii) in which media or publications were these contracts published and on which dates;
- (iv) how much (in rands and cents) were these organisations paid to distribute food; and

(v) why were the services of these organisations sourced whilst the food-bank contracts expire end of March 2024?

4.SD004 Hon. R Nt'sekhe (DA) to ask the Member of the Executive Council for Social Development:

In a committee meeting, the MEC indicated that forensic audits were being conducted within the department. With that in mind:

- (i) has an external service provider been appointed to conduct this audit:
- (ii) if yes to question (I) which persons or organisations;
- (iii) what is the cost of this exercise in rands and cents;
- (iv) what is the time allocated to conducting this investigation and what is the deadline for this investigation to be completed; and
- (v) what percentage of the investigation has been completed?

4.COGTA003 Hon. N de Jager (DA) to ask the Member of the Executive Council for Co-operative Governance and Traditional Affairs, Research and Development:

A recent social media video indicates people have been living on tombstones in Mooifontein cemetery between Birch Acres and Tembisa in Ekurhuleni. With that in mind:

- (i) which security company is contracted to secure this cemetery and when were they contracted;
- (ii) how much in rands and cents have they been paid since their appointment;
- (iii) what is the scope of the work that they have been contracted to do:
- (iv) which department in Ekurhuleni is responsible for the maintenance of this cemetery; and
- (v) when (date) last did they do the maintenance of this cemetery to ensure our loved ones last resting place remains dignified?

4.TR001 Hon. E du Plessis (DA) to ask the Member of the Executive Council for Roads and Transport:

With regard to the below issues, could the MEC please indicate:

- Traffic lights on Hendrik Potgieter
- Traffic lights on the R25 in Ekurhuleni
- The water leak at G-fleet in Ekurhuleni and
- Traffic lights on the R24 at Barbara road
- (i) what specific action has the department taken to repair or replace these traffic lights? (please breakdown per area/road);
- (ii) following the reported malfunctions, were there any temporary measures implemented to manage traffic flow at these intersections (Hendrik Potgieter, R25 in Ekurhuleni, R24 at Barbara Road) while awaiting repairs; and
- (iii) what specific action has been taken to locate and repair the leak to prevent water wastage?

4.COGTA004 Hon. E du Plessis (DA) to ask the Member of the Executive Council for Co-operative Governance and Traditional Affairs, Research and Development:

The municipalities of Merafong, Randwest City, and Mogale in the West Rand reportedly owe Rand Water and Eskom millions of rands. These debts are causing frequent water and electricity outages for residents, sometimes lasting for weeks. With this in mind:

- (i) what immediate interventions will the MEC undertake to address these critical infrastructure and service delivery failures in these municipalities;
- (ii) can the MEC outline a specific debt repayment plan for these municipalities regarding their outstanding balances with Rand Water and Eskom;
- (iii) what long-term infrastructure investment plans are in place to prevent future service disruptions in Merafong, Randwest City, and Mogale;
- (iv) how will the MEC ensure transparency and accountability in the use of any funds allocated to address these issues in the West Rand municipalities; and
- (v) has the MEC considered exploring alternative service delivery models for water and electricity in the West Rand, such as publicprivate partnerships or regional cooperation?

4.TR002 Hon. F P Nel (DA) to ask the Member of the Executive Council for Roads and Transport:

The Tuk Tuk taxis in Eersterust Tshwane has been operating since 2016 and have generated work opportunities for over 600 people. However, the Tuk Tuk taxis are constantly plagued by policing actions by the TMPD as a result of various issues of non-compliance as public transport operators, including the necessary licenses. In light of the aforementioned and the economic impact ceasing operations by the Tuk Tuks will have on the Eersterust community, can the MEC please indicate the following:

- (i) given the large number of taxis operating in this area, can the Department of Transport and Logistics assist the drivers with support to apply and obtain their motorcycle driver licenses;
- (ii) given the large number of taxis operating in this area, can the Department of Transport and Logistics assist the drivers with support to apply and obtain their public driver permits;
- (iii) how can the department assist them with obtaining these licences and permits;
- (iv) how quickly can the department assist them; and
- (v) if it is not possible to assist them, why not?

4.SD005 Hon. B Engelbrecht (DA) to ask the Member of the Executive Council for Social Development:

With regard to NPO funding, could the MEC please indicate:

- (i) NPO business plan advertisements typically go out in October. Why were they delayed in 2023;
- (ii) adjudication processes for funding usually conclude by November. Why have they not been completed yet;
- (iii) traditionally, NPO representatives participated in adjudication panels. Why are they excluded this time;

- (iv) the NPO fiscal year ends on March 31st, with no Service Level Agreements (SLAs) signed. How will NPOs survive the next 3-5 months without funding; and
- (v) the lack of funding could force NPOs to close. What will happen to the children, disabled individuals, and the elderly they serve? How will their basic needs be met?

4.SD006 Hon. B Engelbrecht (DA) to ask the Member of the Executive Council for Social Development:

With regard to Motlhakeng Old Age Home, could the MEC please indicate:

- (i) why is this Old Age Home not operational;
- (ii) twenty-two local residents were trained to work at the home but then dismissed. With ongoing legal cases (CCMA) against the department, can the MEC explain the rationale behind this wasted investment in training and the current status of these cases;
- (iii) another Mothlakeng old age home is overcrowded and in need of upgrades. Given the empty facility and its substantial budget, why wasn't the funding used to improve the existing home and expand its capacity;
- (iv) News reports suggest the facility lacks an occupancy certificate due to non-compliance with health and safety regulations. Can the MEC provide a clear explanation of the outstanding issues preventing the issuance of this certificate; and
- (v) the community needs a solution. What is the department's plan to address the problems hindering the Mothlakeng Old Age Home's opening?

The department reported that the building of the 41 sites has commenced. In addition, it has been reported that a revised catchup plan will be developed by the JV/SITA[1] to provide for sites not completed in Q1 and Q2. Could the MEC please indicate:

- (i) what does the revised catchup plan entail; and
- (ii) how will monitoring of the plan take place to ensure that objectives are achieved?

Hon. N de Jager (DA) to ask the Member of the Executive Council for e-Government:

According to the 2023/24 quarter two annual report, 54 facial number-plate recognition CCTVs were deployed compared to a target of 1500. Alternative supply chain management processes are being implemented since the first tender issued was unresponsive. Could the MEC please

- (iv) did the SLAs of each of the receiving NPOs change based on the increase in number of beneficiaries;
- (v) if no, why not;
