ANNEXURE A

COMPREHENSIVE INSURANCE COVER WORDING

1. Mandatory elements:

- 1.1 Company profile of the bidder, outlining experience, competence, qualified personnel, organogram of the company, methodology proposed on how the GPL portfolio is to be managed.
- 1.2 Detailed benefits, limitations, exclusions, and sum insured for each cover.
- 1.3 All fixed or variable costs must be stated on the proposal. Any relevant or inherent costs such as excess, claim preparation costs and any costs are to be included in the proposal. A fixed combined cost of the premiums in South African Rand inclusive of VAT must be specified. The premiums must be quoted monthly and annually.
- 1.4 Valid registration documents for provision of Financial Services and Short-Term Insurance.
- 1.5 Service providers need to be aligned with the condition of heritage assets that need to be insured (Old and worn-out assets with no cameras/ alarm systems).

2. Policy: Office Contents

Assets to be insured: desks, chairs, couches, cupboards and other moveable items of furniture associated with functional office accommodation.

Sums to be insured: R4 516 672.48

3. Policy: Machinery and Equipment

Assets to be insured: Canteen cooking equipment and security machines that belong to the Gauteng Legislature

Sums insured: R7 302 033.53

4. Policy: Computer and Technical Equipment

Assets to be insured: Laptops, hardware, software, printers, CPUs, screen, televisions, servers, plasmas, digital cameras, software such as SAP, Windows XP Pro, Expert, LIMS, Assets Pro and other software such as the PA system, recording equipment, and other electronic, and technical equipment that belong to the Gauteng Provincial Legislature

Sums to be insured: R 10 259 508.60

6. Policy: Public and employer liability

To be Insured:

- 1) Damages which the insured shall become legally liable to pay consequent upon accidental death, or
- 2) bodily injury or illness, or
- 3) food poising, or
- 4) wrongful arrest, or
- 5) accidental loss of or physical damages to property or third parties (Members of the general public)

Sums to be insured: R105 000 000.00

7. Policy: Group Personal Life and Disability Cover for Members and Staff Insured

The Legislature currently has 69 Members and employs 425 staff members, ranging from junior staff to senior staff. The cover is to be a full 24-hour worldwide cover. The cover is to include cases of death, permanent, temporary disability and medical expenses.

The GPL is currently recruiting and expected to have additional 37 new employees with the 2025/26 financial year and salary budget will be communicated to the successful broker for requote.

8. Group Policy: Members and Employees

- 8.1 There are **425 Employees** of the Gauteng Provincial Legislature with a total Salary of **R355 119.994** er year. The cover must include:
 - 1) Death (natural, accidental),
 - 2) Permanent and temporary disability
 - 3) 5 x annual earnings
 - 4) 24-hour coverage
 - 5) Worldwide coverage (As our staff and Members travel out of South Africa and travel overseas)
- 8.2 There are 69 Members of the Provincial Legislature Total Salary: **R93 562,553** per year
 - 8.2.1 Death (natural, accidental),
 - 8.2.2 Permanent and temporary disability
 - 8.2.3 5 x annual earnings
 - 8.2.4 24 hours of coverage
 - 8.2.5 Worldwide coverage (Staff and Members travel outside South Africa and overseas)

9. Policy: Art collection

The Legislature owns an art collection which consists of plus minus 411 pieces, which are all South African artists.

10. Policy: SASRIA Cover

Insured

Sasria cover for the main building including its contents, in the event of riots, strikes, terrorism, public disorder, or any act or activity which is calculated or directed to bring about a riot, strike or public disorder and damage to the Legislature's property and building.

11. Policy: Heritage Piano

Comprehensive cover for the heritage piano (organ) that is built in at the city hall

12. Policy: Library Books

Insured

Comprehensive cover for all library books for replacement in the event of theft, lost, damage or any eventuality.

Sums to be insured: R2 686 452.30

13. Policy: Main/ City Hall Building

Insured

Comprehensive cover for the main City Hall building including the organ, the cover should be in place to rebuild /restore the building to its original form or replace it to total current value in any eventuality.

Sums to be insured: R671 000 000.00
