## **I. ISINGENISO**

- 1.1. Isishayamthetho Sesifundazwe SaseGauteng sihlose ukwethula futhi siphaside uMthethosivivinywa Wokuchitha Umthetho Wezemisebenzi Yesishayamthetho Sesifundazwe SaseGauteng wonyaka wezi-2025. Lo Mthethosivivinywa uhlose ukuchitha uMthetho Wezemisebenzi Yesishayamthetho Sesifundazwe SaseGauteng, wonyaka we-1996 (uMthetho wesi-5 wonyaka we-1996) futhi uhlizekela izinhlelo zesikhashana namalungiselelo okubhekana noguquko oluzokwenzeka kanye nezindaba ezhlobene nalokho.

## **II. ISENDLALELO**

- 2.1. Amandla namagunya okushaya umtheto ophathelene nohlaka lokuphathwa kwezimali, ukuphathwa kwemisebenzi yansukuzonke kanye nokuhlela, oluqondene nezifundazwe eNingizimu Afrika awela ngaphansi kwemithetho kazwelone. Lokhu kubonakala ngokucacile kwiSinquo Senkantolo YoMthethosisekelo *ecaleni elabe liphakathi kukaNdunankulu Wesifundazwe SaseLimpopo NoSomlomo Wesifundazwe SaseLimpopo Nabanye*<sup>1</sup>. Kulesi sinquo okukhulunywa ngaso lapha iNkantolo YoMthethosisekelo, phakathi kokunye, yakusho kwagcwala umlomo ukuthi uMthetho Wezokuphathwa Kwezimali Zesishayamthetho Sesifundazwe SaseGauteng (uMthetho wesi-7 wonyaka wezi-2009) awuhambisani neze noMthethosisekelo, futhi ngenxa yalokho-ke uyinto eyize leze.<sup>2</sup> Lona nguMthetho owabe uvumela iSishayamthetho Sesifundazwe SaseGauteng, phakathi kokunye, ukuthi sizilawulele ngokwaso umsebenzi wokuphathwa kwezimali kanye nezindaba eziphatelene nokuphathwa kwemisebenzi yansukuzonke eyenziwayo. Lesi sinquo senkantolo esishiwo lapha ngenhla sakubeka kwacaca ukuthi amagunya namandla ezishayamthetho okushaya imithetho, ngokungafani nalawo ePhalamende Likazwelone, lona elinamandla okuthatha izinqumo ngokungenamkhawulo, apherelela kuphela kulokho okuqukethwe kuSheduli 4 no-5 woMthethosisekelo ngokunjalo futhi nasezimweni lapho uMthethosisekelo ukuvumela ngokucacile ukushaywa kwemithetho

“Ngokubona imibono nezindlelakucabanga zamaqembu abandakanyekayo kulolu daba, akudingekile ukuthi silokhu shiso okuningi ngalolu daba. Kucace bha ukuthi imithetho ephambi kwethu, ngaphandle koMthetho WaseNyakatho Ntshonalanga, yonke iyafana kakhulu noMthethosivivinywa waseLimpopo mayelana nenhoso kanye nesakhiwo sayo, okubekwe ngokucacile. Le mithetho ibhalwe ngamagama acishe afane ncimishi futhi ihlose ukulawula ukuphathwa kwezimali zezishayamthetho zezfundazwe. Yonke ibonisa ukuthi amagama assetshenziswe kuyona acashunwe kuMthethosivivinywa ohlanganisa konke owenziwe yiNhlangano yoSomlomo. - 2.2. Umthetho kazweloneke okukhulunywe ngawo ngenhla nguMthetho Wezokuphathwa Kwezimali Zephalamende Nezishayamthetho Zezifundazwe, we-10 wonyaka wezi-2009 (njengoba uchitshiyeliwe).
- 2.3. Empeleni uhlanganisa futhi ufingqe wonke amaphuzu asemqoka ohlaka Iwemithetho elawula uhlaka lokuphathwa kwezimali, ukuphathwa kwemisebenzi yansukuzonke kanye nokuhlela, okuwuhlaka oluqondene nephalamende kanye nezishayamthetho.
- 2.4. Ngonyaka we-1996, iSishayamthetho SaseGauteng saphasisa uMthetho Wezemisebenzi Yesishayamthetho Sesifundazwe SaseGauteng, wonyaka we-1996 owaphasiswa ngaphambidlana nje kancane koMthethosisekelo WeRiphabhulikhi YaseNingizimu Afrika, wonyaka we-1996. Lo Mthetho wabe uhlose, phakathi kokunye, ukuhlinzekela “*ukusungulwa koPhiko Lwezemisebenzi Yesishayamthetho, ukusungulwa kweBhodi Lezemisebenzi Yesishayamthetho, ukuhlela nokuphathwa koPhiko Lwezemisebenzi, ukunquma ngesabelomali soPhiko Lwezemisebenzi, kanye nezindaba ezihlobene nalokho*”.
- 2.5. Kodwa-ke, sekube nongabazane nokungagculiseki kahle ngokuthi ngempela lo Mthetho uyahambisana yini noMthethosisekelo. Okokuqala, njengoba kubonisiwe lapha ngenhla, lo Mthetho washaywa ngaphambi koMthethosisekelo WeRiphabhulikhi YaseNingizimu Afrika wonyaka we-1996 futhi wabe ulandela uMthethosisekelo Wesikhashana wonyaka we-1993. Ngakho-ke, ukushaywa kwalo Mthetho, nakuba kwabe kunezinhloso ezinhle, kwabe kungaphandle kwegunya namandla esishayamthetho okushaya imithetho. Lokhu kwabe kungahambisani noMthethosisekelo, wonyaka we-1996 kanye noMthetho Wezokuphathwa Kwezimali Zephalamende Nezishayamthetho Zezifundazwe, we-10 wonyaka wezi-2009 (njengoba uchitshiyeliwe).
- 2.6. Okwesibili, iningi lezimiselo zoMthetho azihambisani noMthethosisekelo kanye nohlaka Iwemithetho lukazweloneke njengoba kubekwe ngokucacile lapha ngenhla. Izimiselo ezigqamile yilezo okuthiwa yizona ezsungula isishayamthetho, imisebenzi yaso kanye neBhodi Lezemisebenzi Yesishayamthetho, zonke ezingahambisani neze noMthethosisekelo kanye noMthetho Wezokuphathwa Kwezimali Zephalamende Nezishayamthetho Zezifundazwe, we-10 wonyaka wezi-2009 (njengoba uchitshiyeliwe). IBhodi Lezemisebenzi Yesishayamthetho linikezwa amandla eSiphathimandla Esiphezulu ngenkathi lingaphansi kwesandla sikaSomlomo njengoSihlalo walo, futhi ngokoMthethosisekelo kanye nohlaka Iwemithetho lukazweloneke uSomlomo nguyenka kanye oyiSiphathimandla Esiphezulu. Futhi uMthetho unezimiselo eziphathelene, ukwenza nje isibonelo, neBhodi Lamathenda Lesifundazwe okuthiwa yilona elibhekene nezindaba eziphathelene nokuthengwa kwempahla nezinsizakalo, okuyizimiselo osekudala zaphelelwa yisikhathi njengoba esikhundleni sazo sekunohlaka Iwemithetho lukazweloneke okuyilona olusebenzayo.
