## **FOREWORD OF THE REGISTER FOR MEMBERS' INTERESTS**

As the custodian of the Register of Members' Interests, the Office of the Integrity Commissioner plays a critical role in safeguarding transparency and accountability by Members of the Gauteng Provincial Legislature (GPL).

Members of the Provincial Legislature (MPLs) occupy positions of public trust, which demand the highest standards of integrity and ethical conduct. Consequently, the annual disclosure of Members' registrable Interests is a fundamental instrument in promoting transparency and accountability. It enables oversight, reinforces public confidence and supports the principle that public office must be exercised in the best interest of the people of Gauteng.

In fulfilling this obligation, MPLs contribute to strengthening the credibility of the GPL and upholding the values that underpin our constitutional democracy.

The obligation to annually disclose registrable interests is not optional, it is an ethical imperative. It ensures that any potential or perceived conflicts of interest are identified and managed and therefore ensures that legislative decisions remain beyond reproach. The disclosure of Members' registrable interests gives expression to a shared commitment by MPLs to uphold ethical standards and lead by example.

It is therefore encouraging that in this cycle all MPLs have submitted their e-disclosure forms, including the Member who joined on the eve of the end of the declaration period. It is the right thing to do.

In embracing this responsibility, MPLs not only comply with the CODE but contribute to strengthening public confidence in the GPL and the democratic process as a whole. By complying fully and consistently with the CODE, MPLs reaffirm their commitment to integrity, strengthen institutional credibility, and uphold the trust that citizens of Gauteng place in their elected representatives.
